State Training & Employment Program (STEP) CNA Training Funding Guidelines

Orientation and Q&A August 2 & 11, 2023

AHHA received STEP funding to support training CNAs between July 1, 2023, and June 30, 2024.

Facilities are encouraged to utilize the "employment first" model of hiring trainees in a non-licensed role and paying them for work and training hours while they complete training, although wages to a trainee are not eligible expenses for reimbursement.



Programmatic Criteria

TRAINING

The facility must provide a state-approved CNA training program, either in-house or through an outside training program.

COMPLETION

Reimbursement not contingent upon passing the certification exam, but employers are expected to support trainees in completing training, applying for certification, and passing the exam.

REIMBURSEMENT

The grant will reimburse up to \$3,000 of eligible expenses per participating trainee.



Changes

AHHA received less funding than requested, and less than last year.

How funds are being allotted

Maximum support was determined based on number of participating facilities in FY23, allowing for the addition of new participants.

Maximum support

Funding can support 6 trainees per participating facility; maximum of \$3,000 per student to be reimbursed.

Change in reimbursable expenses

Wages paid to a trainee for work or training hours are no longer an eligible reimbursable expense.

Assessing programmatic data in early 2024

It may be determined that sites with capacity and interest can be allotted additional funds in order to train as many CNAs as possible and expend STEP funding before June 30.

- Coordinator's time to support trainees
- Cost of training (expenses related to training in-house or tuition paid to an external program)
- Training supplies
- Textbook/workbooks
- o BLS / CPR training costs
- Background check / fingerprinting / drug screen fees
- Certification exam / certification fees

- Submit a STEP Participation Form for each CNA trainee
- After training, complete an online Reimbursement Request for each trainee indicating expenses and progress


